

Riverside Road Area – Proposed Permit Parking Area – Informal Consultation Results

An informal consultation was carried out with properties within the Riverside Road Area on a proposed Permit Parking Area. Consultation was carried out between the 11/02/2022 and 04/03/2022.

Summary of responses per question.

Q3: Are you a resident of business? 93 Resident 0 Business, Total 93

Q4 How many vehicles do you currently have in your household?

No Vehicle 8 Responses, 1 Vehicle 44 Responses, 2 Vehicles 26 Responses, 3 Vehicles, 9 Responses. Over 4 Vehicles 6 Responses, Total 93

Q5 How many of your vehicles do you currently park off street e.g. on private driveways or garages)?

1 Vehicle Owner (Vehicles Parked Off Street, 16)

2 Vehicle Owner (Vehicles Parked Off Street, 21)

3 Vehicle Owner (Vehicles Parked Off Street, 10)

4 or more Vehicle Owner (Vehicles Parked Off Street, 18)

Q6 How many of your vehicles do you currently park on street?

1 Vehicle Owner (Vehicles Parked On Street, 44) Note 5 Respondents ticked both on and off street

2 Vehicle Owner (Vehicles Parked On Street, 31)

3 Vehicle Owner (Vehicles Parked On Street, 18) Note 1 Respondent ticked both on and off street

4 or more Vehicle Owner (Vehicles Parked On Street, 7)

Q7 Do you own an Electric Vehicle or have any intention of purchasing an Electric Vehicle prior to the end of 2023?

Yes: 13 Responses, No 79 Responses, Total 92 Responses (1 respondent did not answer question).

Q8 Do you support the principle of the proposals to introduce a Permit Parking Area to be operational between Monday to Saturday 1pm to 3pm in the Riverside Road Area ? Yes: 52 Responses, No 41 Responses, Total 93 Responses

Q9 Do you support the principle of an Electric Vehicle charging point and bay being introduced in the Riverside Road Area, subject to an appropriate location being found? Yes: 58 Responses, No 33 Responses, Total 91 Responses (2 respondents did not answer question).
