#### ROAD TRAFFIC REGULATION ACT 1984 THE BOROUGH OF WATFORD (VARIOUS ROADS, WATFORD) (PROHIBITION OF WAITING) ORDER 2021

#### WBC Order 21/03

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangement for discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council, and in exercise of powers conferred on that Council under sections 1, 2, 4, 32, 35, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

# PART ONE - INTRODUCTION

#### **CITATION**

**1.1** This Order shall come into operation on XXXX 2021 and may be cited as THE BOROUGH OF WATFORD (VARIOUS ROADS, WATFORD) (PROHIBITION OF WAITING) ORDER 2021.

#### **INTERPRETATION**

- **1.2** In this Order, except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or schedule in this Order.
- **1.3** In this Order any reference to an Act, Statutory Instrument, Regulation or Order shall be construed as a reference to that Act, Statutory Instrument or Order as amended.
- **1.4** In this Order the following expressions shall have the respective meanings assigned to them:

"Civil Enforcement Officer" means a person appointed in accordance with the provisions of Section 76 Traffic Management Act 2004

"Disabled Person's Vehicle" means a vehicle displaying a valid Disabled Persons Badge and Parking Disc

"Disabled Persons Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 2000

"Parking Disc" has the same meaning as in the Disabled Persons (Exemptions for Disabled Persons) (England) Regulations 2000

"Council" means Watford Borough Council

"Passenger Vehicle/s" means a Motor Vehicle constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the Driver, and not drawing a trailer

"Motor Vehicle" has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984

# PART TWO – RESTRICTIONS

### NO WAITING AT ANY TIME

**2.1** No person shall cause or permit any vehicle to wait at any time in the lengths of road specified in Columns 1, 2 and 3 in Schedule 1 to this Order.

### NO WAITING MONDAY TO SATURDAY 6AM to 6.30PM

**2.2** No person shall cause or permit any vehicle to wait at any time in the lengths of road specified between the period of Monday to Saturday 6am to 6.30pm, in Columns 1, 2 and 3 in Schedule 2 to this Order.

### <u>1 HOUR LIMITED WAITING MONDAY TO SUNDAY 8AM to 8PM. NO RETURN</u> WITIHN 1 HOUR.

2.3 The area of carriageway specified in Columns 1, 2 and 3 in Schedule 3 to this Order, are authorised for use as parking bays, with limited waiting for 1 hour period between Monday to Sunday 8am to 8pm with no return within 1 hour.

# LOADING ONLY 8AM TO 8PM MONDAY TO SUNDAY.

2.4 The area of carriageway specified in Columns 1, 2 and 3 in Schedule 4 to this Order, are authorised for use for vehicles loading or unloading only between the hours of 8am to 8pm Monday to Sunday.

# DISABLED BADGE HOLDERS ONLY

2.5 The area of carriageway specified in Columns 1, 2 and 3 in Schedule 5 to this Order, are authorised for use only for vehicles displaying a Disabled Persons Badge, in the relevant position of the vehicle.

# PART THREE - EXEMPTIONS

### **EXEMPTIONS**

- **3.1** Nothing in Articles 2.1 & 2.2 of this Order applies to the lengths of road restricted by that Article (which said lengths of road are referred to in this Article as "the restricted area") in relation to
  - (a) a vehicle being used for Fire and Rescue, Ambulance or Police purposes.
  - (b) anything done with the permission of or at the direction of a Police Constable in uniform; or with permission of a Civil Enforcement Officer

as defined by the Traffic Management Act 2004 and appointed by Watford Borough Council.

- (c) a vehicle which is prevented from proceeding by circumstances beyond the drivers control or which has stopped in order to avoid injury or damage to persons or property or when required to do so by law;
- (d) a vehicle which is stationary in order that it may be used for one or more of the purposes specified in Article 3.2 and which cannot reasonably be used for such a purpose without stopping in the restricted area;
- (e) a marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may be reasonably necessary for postal packets to be delivered or collected;

In this Article –

The expressions "universal service provider", "provision of a universal postal Service" and "postal packet" shall bear the same meanings as in Section 65 of the Postal Services Act 2011.

- 3.2 The "purposes" referred to in sub-Article 3.1(d) of this Article are -
  - (a) any operation involving building, demolition or excavation;
  - (b) the removal of any obstruction to traffic;
  - (c) the maintenance, improvement, or reconstruction of a road;
  - (d) constructing, improving, maintaining, or cleaning of any street furniture; or
  - (e) the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.
- **3.3** Nothing in Articles 2.1 & 2.2 of this Order applies to the lengths of road restricted by that Article (which said lengths of road are referred to in this Article as "the restricted area") so as to render it unlawful to cause or permit any vehicle to wait only for so long as may be reasonably necessary
  - (a) to enable goods to be loaded on or unloaded from the vehicle from or to premises adjacent to the restricted area; or
  - (b) to enable a passenger to board or alight and to load and unload any luggage.
- **3.4** Nothing in Articles 2.1 & 2.2 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc, to wait at any time in the lengths of road specified in Schedule 1 of this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).
- **3.5** Save as provided in Article 2.3, the driver of a vehicle shall not permit the vehicle to wait in those parking bays unless it is; a) wholly parked within the marked limits of the parking bay and b) waiting for no more than 1 hour (not

being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of restriction)

**3.6** A vehicle parked in a parking bay in contravention of Article 2.3 of this order or parked otherwise in accordance with the provisions of this Order shall incur a penalty charge

# PART FOUR -REVOCATIONS

# REVOCATIONS

- 4.1 In accordance with Part IV of Schedule 9 of the 1984 Act, the following parts of the following Order are to be revoked only in respect to the lengths of roads affected by this Order as specified below.
- 4.1.1 The Hertfordshire (Balmoral Road, Southfield Avenue, Knutsford Avenue, Devon Road, Eastfield Avenue, Westfield Avenue, Watford)(Prohibition of Waiting) Order 2004
