

NOTICE OF PROPOSAL

THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2018 (AMENDMENT) (NO. 19) ORDER 2023

NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under sections 1, 2, 4, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers.

The general effect of the Order will be to amend waiting restrictions as follows:

- **St. Johns Road** (both sides) Implement no loading at any time above the existing no waiting at any time east of the junction with St. Albans Road
- **St. Johns Road** (south side) Convert and mark 5 metres of the existing permit holder bay to a loading bay, to operate as Loading only 8am - 10pm, 30mins No return within 1hr
- **Percy Road** (both sides) Introduce 3 metres of no waiting and no loading at any time from junction with Market Street
- **Market Street** (east and west side), Introduce 5 metres of no waiting and no loading at any time from junction with Percy Road
- **Sydney Road** (north Side) Introduce 7 metres of no waiting at any time across the access road to the garages, east of no. 2 Sydney Road
- **Sydney Road** (north Side) Relocate existing Permit Holders Only bay east of no. 2 Sydney Road further east by 2 metres.
- **Cambridge Road** (both sides) Implement no loading at any time above the existing no waiting at any time on the north and south of the junction with Granville Road
- **Granville Road** (both sides) Implement no loading at any time above the existing no waiting at any time on the west of the junction with Cambridge Road
