

## NOTICE OF PROPOSAL

### WATFORD BOROUGH COUNCIL

#### THE BOROUGH OF WATFORD (VARIOUS ROADS, PART A WATFORD) (PROHIBITION OF WAITING RESTRICTIONS) ORDER 2023

NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council (the County), and in exercise of the powers conferred on that County under sections 1, 2, 4, 32, 35, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

1. The general effect of the order would be to provide **'No Waiting At Any Time'** waiting restriction at the following locations.

- On **Southwold Road**, east side of its junction with the private access car park
- On **Service Road Q (off Beechen Grove)**, west of the existing Electric vehicle charging bay
- On the north side of **Riverside Road**, around the access of **Riverside Road Industrial Units** and on the south side within the turning circle adjacent to the access of **Luterola Close**
- On western side **Perivale Gardens**, around property no. 17 where the carriageway bends north-western direction
- On the north side of **Woodmere Avenue**, just east of its junction with **Douglas Avenue**
- On the north side of **The Brow**, around the access into **Alban Wood Primary School and Nursery**

2. The effect of the order is to provide **No Waiting At Any Time'** and **'No Loading At Any Time'** waiting restriction at the following locations:

- On the **Rickmansworth Road**, just off the roundabout with the A411 and adjacent to frontages of the Parade.
- On both sides of the **Service Road Q (off Beechen Grove)** to the highway extents
