THE BOROUGH OF WATFORD (WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2023

- 1. Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under sections 1, 2, 4, 32, 35, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, made an Order on July 20th 2023 consolidating the following Orders and Notices:-

- 2. The effect of the new Order will be to revoke the above Orders, but the provisions contained in those Orders will remain in force unchanged by virtue of the new Order. That is to say that:-
 - (a) Controlled Parking Zones are established in Watford Central Area, West Watford, the Callowland area of North Watford and Oxhey.
 - (b) no one is allowed to leave any vehicle in the roads or parts of roads specified in the Order other than in accordance with the provisions of the Articles and the Schedules of that Order.
 - (c) Provisions are laid down for the control of the issue, charge and use of permits and tickets and for the control of the issue of penalty charge notices and the recovery of penalties
- 3. Exceptions in the Order will permit waiting for the following purposes:-
 - (a) the picking up and setting down of passengers
 - (b) the loading and unloading of goods
 - (c) the carrying out of essential services connected with the maintenance of the road and the supply of gas, water, electricity and telecommunications.
 - (d) A vehicle waiting upon the direction or with the permission of an authorised person.
- 4. The Order contains provisions for the removal and safe custody of a vehicle contravening the provisions of the Order and for the recovery of the costs of so doing.

- 6. The Order will come into effect on August 8th 2023.
- 7. Any person wishing to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the date of this Notice apply to the High Court for this purpose.
