THE BOROUGH OF WATFORD (VARIOUS ROADS, PART B WATFORD) (PROHIBITION OF WAITING RESTRICTIONS) ORDER 2023

NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council (the County), and in exercise of the powers conferred on that County under sections 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

- 1. The general effect of the order would be to provide 'No Waiting At Any Time' waiting restriction at the following locations.
 - At the junction of **Dell Road** and **Chestnut Walk** with **The Harebreaks**
 - At the junction of **Dell Side** with **The Harebreaks**
 - At the junction of **Melia Close** with **St. Albans Road (2**4 metres in the northern direction and 11 metres in the southern direction on St Albans Road, and 5 metres into Melia Close)
 - At the junction of Balmoral Road with Imperial Way
 - On the northern side of Trinity Hall Close, further west of its junction with St. Pauls Way (an
 extension from the existing double yellow lines)
 - On the southern side of **Trinity Hall Close**, around the kerb buildout outside property no. 7
 - At the junction of Louvain Way with the Lyndon Court.
- 2. The effect of the order is to provide 'No waiting and No Loading At Any Time' restriction at the following locations:
 - On northern side of **Berry Avenue**, in the western direction to the start of the roundabout
 - On southern side of **Berry Avenue**, in the western direction to the access road into Cherry Tree School.
 - On the northern side of the access road into Cherry Tree School
- 3. The effect of the order is to provide 'Monday to Friday 10am 4pm' waiting restriction at the following location:
 - Berry Avenue, on the northern side of the roundabout leading into Cherry Tree School
 - 4. The effect of the order is to provide 'Limited Waiting 2 hours, no return within 30 minutes between 8am and 6.30pm on Monday to Friday inclusive' waiting restriction at the following location:
 - Chalk Hill, inset parking bay, on the southern side, outside no. 79 to 83
