#### THE BOROUGH OF WATFORD

#### (OFF-STREET PARKING PLACES) ORDER 2019 (AMENDMENT) (NO.8) ORDER 2025

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 32, 33, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and Part 6 of the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

- This Order may be cited as THE BOROUGH OF WATFORD (OFF STREET PARKING PLACES)
   ORDER 2019 (AMENDMENT)(NO.8) ORDER 2025 and shall come into operation on the XXXX
   July 2025.
- 2. The provisions of The Borough of Watford (Off Street Parking Places) Order 2019 ("the 2019 Order") as amended are hereby amended in accordance with Articles 3 of this order.
- 3. Within Schedule 1 Item 1-7 of the 2019 Order, the bays described will be revoked from the 2019 Order.
- 4. Within Schedule 2 Item 1-7 of the bays described will be amended in the 2019 Order.
- 5. In this Order the following expressions shall have the respective meanings assigned to them:

"bay markings" means white or yellow lines marked on the surface of a parking place to indicate the limits of each individual parking bay within this order

"charging hours" means the period of time specified in relation to a parking place or part thereof in Column 6 of Schedules 1;

Operational Electric Vehicle: Electric or Hybrid vehicles owned or leased by Watford Borough Council and used for operational purposes

"electric vehicle" means a vehicle in which the electrical motive power is derived from an electrical storage battery which is not connected to any other source of power when the vehicle is in motion;

- "parking bay" means an area within a parking place which is provided for the leaving of one vehicle only and is indicated by bay markings on the surface of the parking place
- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
