

## NOTICE OF PROPOSAL

### THE BOROUGH OF WATFORD (OFF STREET PARKING PLACES) ORDER 2019 (AMENDMENT) (NO.9) ORDER 2026

NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council, proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under Sections 45, 46, 46A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (referred to as “the Act”) and all other enabling powers.

The general effect of the Order will be:

- A) To remove the flat rate evening tariff at the following Car park locations
- B) Vary the parking charges payable
