## **Commercial Street Trading Consent Standard Conditions**

1. The consent-holder may employ agents if required, providing the consent-holder exercises proper control over the stall or vehicle at all times and the names of those agents are notified to the council in writing.
2. The consent-holder must ensure that this consent is displayed on the stall or vehicle at all times.
3. The consent-holder or his agent must ensure that they implement a Litter Management Strategy as set out on the enclosed leaflet.
4. The consent holder(s) shall not cause any nuisance or annoyance to any other user of the highway, the occupier or nearby premises.
5. No recorded or amplified music or radio shall be played by the consent holder(s) or any agent at the stall to the annoyance of any member of the public, local resident or occupier of nearby premises.
6. No water, rubbish or waste material shall be discharged or deposited on the highway or any adjacent property into any surface water inspection chamber or gully.
7. If this consent is granted for street trading from a trailer vehicle:
  - (1) the towing vehicle may not be parked on any footway or part of a footway;
  - (2) this consent does not give permission for the holder to park any towing vehicle where waiting is normally prohibited.
8. The consent is personal to the consent holder(s) and is not transferable. The consent automatically determines upon the death of the consent holder(s), or in any event of any legal or physical incapacity substantially preventing the consent holder(s) from personally operating the stall to which it relates. The rights conferred by this consent may not be assigned, sublet or otherwise transferred, whether for value or not, and the consent holder(s) may not enter into any agreement whereby any other person is allowed to operate or assist in the operation of the stall to which this consent relates in return for a consideration calculated by reference to the income received by the operation of the stall.
9. Failure to comply with these conditions will put the consent holder(s) at risk of having the consent revoked and/or of prosecution.
10. Any additional conditions shown below.

## **Commercial Street Trading Consent Litter Management Strategy**

1. The stall holder shall ensure all food and drink packaging dispensed on trading from the stall bears a permanent trading mark on other agreed means of specific identification.
2. The stall holder shall provide a temporary litter bin on site of not less than 75 litres capacity prior to commencing and until one half hour after trading and empty as necessary for the duration of trading activity.
3. The stall holder shall manage the litter in the vicinity of the stall as follows:
  - a) Prior to vacating the site the stall holder shall sweep and remove all food debris and litter to achieve Grade A (as defined in the Environmental Protection Act 1990 Code of Practice on Litter and Refuse), and wash down and remove any spillages as necessary, to a distance of 5 metres from the stall and litter pick all other identifiable packaging as set out in condition 1 above to a distance of 15 metres from the stall
  - b) At all times during trading the stall-holder shall monitor the level of identifiable packaging as set out in condition 1 above to a distance of 15 metres from the stall and where the standard of cleanliness falls to Grade C or lower therein shall immediately clear the area of identifiable packaging to achieve Grade B.
  - c) All litter and waste arising from the above activities shall be removed by the stall holder as trade waste.
