- The personal information we collect about you
- What we do with your information, and
- Who your information may be shared with

Who we are

Watford Borough Council ('we' or 'us') are a 'data controller' for the purpose of the General Data Protection Regulations, (i.e. we are responsible for, and control the processing of, your personal information).

This notice explains why we ask for your personal information, how that information will be used and how you can access your records.

Purpose for processing and legal basis?

We will use the information collected to:

- record your attendance at an event
- collect your feedback in respect of an event
- respond to any queries you have in relation to the event
- Research or Customer Satisfaction requirements
- Records of supplier details to ensure the delivery of contracts
- Safeguarding: Child protection and adults at risk

We use your information to administer and deliver public services e.g. we use social media to broadcast messages and updates about events and news. On occasion we may reply to comments or questions you make to us on social media platforms.

Information we collect

We collect the following information such as:

- Childs name
- Emergency contact name and number (Parent / responsible adult)
- Childs age
- Any health related problems or disability
- Childs gender
- Ethnicity

Some examples of when we collect this information include:

 Registration to access the free activities programme delivered on behalf of Watford Borough Council- Wat's On

How we use the information we collect

We may share your information with the following third parties such as:

- Council's internal department

Where the Council engages third parties to process personal data on its behalf, they do so on the basis of written instructions, are under a duty of confidentiality, and are obliged to implement appropriate technical and organisational measures to ensure the security of data.

Watford Borough Council may also share personal information with the police and other local authorities under Article 23 of the General Data Protection Regulations in order to prevent or detect crime.

How long the data will be stored?

Data is stored for the duration of each programme cycle. A cycle is either an Easter holiday or summer holiday.

New registration will need to be completed each cycle if returning to use the service. Once the management report is completed for that cycle (approximately 3 weeks after the last session day) all identifiable data will be destroyed.

Keeping your information secure

We will use technological and organisation measures to keep your information secure. These measures may include the following examples:

- All data is stored on a database on a secure server which are password protected.
- All payment processing is done using Axis Income Management compliant systems.

Research & Statistics

Anonymised & Pseudonymised data may be used for research and statistical purposes. Any data collected may be used for research and statistical purposes that are relevant and compatible with the purpose that the data was collected for.

What rights do you have?

Your duty to inform us of changes it is important that the personal information we hold about you is accurate and current. Please keep us informed if your personal information changes.

Your rights in connection with personal information under certain circumstances, by law you have the right to:

- Request access to your personal information (commonly known as a "data subject
 access request"). This enables you to receive a copy of the personal information we
 hold about you and to check that we are lawfully processing it.
- **Request correction** of the personal information that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- Request erasure of your personal information. This enables you to ask us to delete or remove personal information where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal information where you have exercised your right to object to processing (see below).
- **Request the restriction** of processing of your personal information. This enables you to ask us to suspend the processing of personal information about you, for example if you want us to establish its accuracy or the reason for processing it.

If you want to review, verify, correct or request erasure of your personal information, object to the processing of your personal information, or request that we transfer a copy of your personal information to another party, please contact the Data Protection Officer in writing.
