**TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT) ORDER 1995 AS AMENDED**

**DIRECTION MADE UNDER ARTICLE 4 (1)**

WHEREAS the Council of the Borough of Watford being the appropriate local planning authority within the meaning of article 4(4) of the Town and Country Planning (General Permitted Development) Order 1995, as amended, are satisfied that it is expedient that development of the description set out in the Schedule below should not be carried out on the following list of addresses, unless permission is granted on an application made under Part III of the Town and Country Planning Act 1990 as amended: **186, 201, 203, 205 Pinner Road; 31, 33 Sherwoods Road; 1, 2, 3, 4, 5, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37 Watford Heath.**

NOW THEREFORE the said Council in pursuance of the power conferred on them by article 4(1) of the Town and Country Planning (General Permitted Development) Order 1995, as amended, hereby direct that the permission granted by article 3 of the said Order shall not apply to development on the said land of the description(s) set out in the Schedule below.

THIS DIRECTION is made under article 4 (1) of the said order and, in accordance with the article 5(4), shall remain in force until 4<sup>th</sup> October 2013 (being six months from the date of this Direction) and shall then expire unless it has been confirmed by the Council.

**SCHEDULE**

Development within the curtilage of a dwellinghouse comprised within the following classes of Part 1 of Schedule 2 to the said Order:

Class A – enlargement, improvement or other alteration;

Class C – any other alteration to the roof;

Class D – the erection or construction of a porch outside any external door.

Development within the curtilage of a dwellinghouse comprised within the following classes of Part 2 of Schedule 2 to the said Order:

Class A – the erection, construction, maintenance, improvement or alteration of a gate, fence, wall or other means of enclosure.

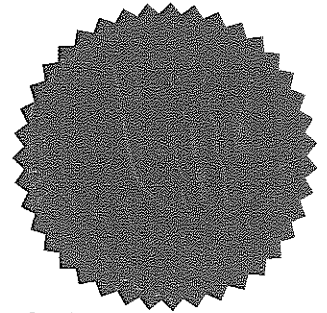
Class C – the painting of the exterior of any building or work.

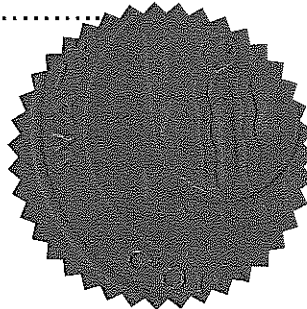
