NOTICE IS HEREBY GIVEN that Watford Borough Council, acting as agents for Hertfordshire County Council proposes to make the above-mentioned Order pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under sections 1, 2, 4, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers.

The general effect of the Order will be to amend waiting restrictions as follows:

- Estcourt Road (East Side), Central Ward (introduce extension of no waiting and no loading at any time, and provide additionally 10 metres extension of permit parking only 8am-10pm)
- Loates Lane & Lord Street (Both Sides), Central Ward (implement no loading at any time above the existing no waiting at any time).
- Queens Road (West Side), Central Ward (implement no loading at any time above the existing no waiting at any time from the junction between a point 15 metres south of it junction with Prince Street to the junction of Loates Lane).
- Orphanage Road (North West Side), Central Ward (implement no loading at any time above the existing no waiting at any time between the junction with Woodford Road and the railway bridge)
- Cross Street (North Side), Central Ward (replace 11metres of no waiting at any time with No Waiting Monday to Saturday 8am-6.30pm).
- St Johns Road (South Side), Central Ward (Reinstate 56 metres of permit parking only 8am-10pm)
- Farraline Road (East Side), Vicarage Ward (Convert No Waiting Mon-Saturday 8am-6.30pm with No Waiting at Any Time.
